## Registration Form and Contract : Terms and Conditions

Playworks Childcare cares for the children in our charge and for the feelings and concerns of their parents. Playworks Childcare Ltd wishes to work with you to provide the best quality childcare and play opportunities in a pleasant, caring and learning environment.

### **Playworks Childcare Ltd agrees that:**

- The Club will be open in accordance with the correspondence sent to you upon registration.
- All fees will be in accordance with our fees policy and payable in advance as stated in the payment schedule/ invoice for your child/ children.
- Charges during absence will be in accordance with our admissions policy
- Playworks Childcare will ensure that children are delivered to and collected from the school according to our arrival and collection policy
- Children will be handed over only to the adult(s) who have been identified on the registration form at the end of each session
- If a child becomes ill whilst attending a session we will inform the named contact and the child will be looked after in a quiet area until collected. The child will be observed for any worsening symptoms. The parent/Carer will be notified verbally the same day at the end of the session
- Medicines will only be administered according to our medical policy
- Playworks Childcare will arrange alternative cover in the case of staff absence
- Playworks Childcare will treat all children as individuals and endeavour to meet their specific needs
- Playworks Childcare will take account of each child's special dietary needs
- In the case of emergencies, please see our emergency procedure policy
- Playworks Childcare will provide a relaxed and friendly environment where children are free to choose from a wide range of play opportunities. Any behaviour which is likely to lead to the safety and enjoyment of others being compromised will be dealt with in accordance with our behaviour policy
- Playworks childcare will make sure that all parents/Carers are aware of any changes to the Club's policies and procedures.
- Playworks Childcare will act on any complaint as explained in our complaints procedure.

### **Playworks Childcare asks in return that:**

- You book and pay for your child's place in advance as set out in your Payment Schedule/ invoice.
- You give notification if your child is unable to attend the Club if a place has been reserved for them
- You pay for all booked sessions including those where the child cannot attend e.g. for sickness and/or holidays
- You give notification if your child is unable to attend the Club if they have contracted a communicable or infectious disease, which is required under health and safety legislation
- You regularly update us of changes in authorised persons able to collect your child, or changes in doctor's details, or changes of address
- You will keep us informed of any changes that may affect your child's well-being
- You give a minimum of one month to terminate your contract with us.

## **ACTIVITIES**

Some of the routine activities of the Club may involve off-site visits e.g. park. For your child to take part in these activities you will be asked to sign a consent form.

## **PHOTOGRAPHS**

Photographs may be taken of the children for the Club's journal. Specific permission will be sought to use any photographs or video material if they are to be used outside the Club premises.
